

PRIVACY POLICY

ROCKET MOVERS LIMITED

This policy outlines the ways in which Rocket Movers Limited and its related entities ("We") collect, use, disclose, store, secure, manage and protect your Personal Information in accordance with the New Zealand Privacy Act 1993 Privacy Principles.

Where the words "Personal Information" are used in this policy, that expression means information about an identifiable individual (a natural person).

The Kinds of Personal Information We Collect and Hold

The kinds of Personal Information we collect from you may vary depending upon the nature of the services you have instructed us to provide. Generally, we will collect information regarding your name, contact details, date of birth, drivers licence number, creditworthiness, credit card details and loyalty program membership details if applicable. It is necessary or desirable for us to collect this Personal Information in order to provide you with trailer, utility or equipment rental services.

How We Collect and Hold your Personal Information

We will collect your Personal Information where practicable from you directly, usually through telephone, email or face to face communication, through your completion of a hire-related form, your completion of an online booking, your subscription to a mailing list, or any combination of these. We may also however obtain your Personal Information from:

- (a) Third parties who make a booking with us on your behalf;
- (b) Our employees, agents or contractors;
- (c) Third party agencies contracting with us in order to obtain or to provide marketing information to improve the quality of the goods and services which we (or they) provide;
- (d) Credit reporting agencies to obtain creditworthiness information about you; or
- (e) Government Departments or Agencies by undertaking searches or by request.

The Purposes for which we Collect, Hold, Use and Disclose your Personal Information

We collect, hold, use and disclose your Personal Information for the following purposes (which you authorise us to do on each occasion where you apply to hire a trailer from us or our agents or contractors):

- (a) Providing trailer or equipment rental services to you or someone else at your request;
- (b) Verifying your identity and current motor vehicle licence;
- (c) Verifying your creditworthiness;
- (d) Administering any loyalty program that we may offer customers from time to time;
- (e) Providing you with information about other services that we, our related entities and other organisations that we have affiliations with, offer that may be of interest to you;

- (f) Providing information to any of our related entities or to any other entity that supports the provision of our services and products, including as to storage of your Personal Information, or to any other third party entity for the purposes of marketing their services and products to you (and in each such case the other entity concerned may be located within or outside New Zealand);
- (g) Facilitating our internal business operations, including the collection of money that you owe us (including authorising and processing credit card transactions), protecting and enforcing our legal rights and remedies and the fulfilment of any legal requirements; and
- (h) Analysing our services and client needs with the view of developing new or improved services.

How you May Access or Seek the Correction of Personal Information Held by Us

Our Website

We collect website activity statistics such as the number of visitors, pages visited, time and date of visit and where you accessed our website from, so that we can make informed decisions relating to improving our website and blogs and the services we deliver. This information is anonymous and doesn't identify a person.

When you visit our website www.rocketmovers.co.nz a cookie is placed on your computer. The cookie does not contain personal information that can identify you, but may contain information about the page you visited on our website. If you do not wish for this to occur, you can remove cookies from your computer, by following the standard procedures applicable to your internet browser.
